- Understand and fully comply with all relevant legislation, customer and compliance requirements including:

 - Construction (Design and Management) Regulations 2015.
 - REACH regulations and the requirements of "The Safe Drinking Water and Toxic Enforcement Act of 1986" (PROP 65).
 - Creating a register of compliance regulations that is regularly reviewed.

Operational we will:

- Ensure all our products meet national and international standards and specifications, including CE Marking, REACH etc. and any other applicable requirements.
- Ensure all of our products meet the requirements of the relevant regulations around the world and a life-cycle approach is taken in development process.
- Organise those operations to ensure that the effect they have on the environment is minimised.
- Reduce the consumption of energy and materials where possible and reuse or recycle unwanted items.
- Protect the local and wider communities from pollution or nuisance as a result of our operations.
- Monitor and reduce the waste streams generated by our business and continue to ensure that our primary waste stream is separated sufficiently so that it can be processed and used again as a recyclate (<- is that correct word) feed stock for other processes.
